1.1 Test Method and Condition:

Test method: IEC 60529:1989+AMD1:1999+AMD2:2013 CSV/COR2:2015

Test quantity: 1 pc

Test condition:

1. Push a 1mm diameter test wire into the opening of the specimen with a force of $1 \pm 0.1N$.
2. Place the sample into a test chamber containing 2kg of talc powder per cubic meter to begin the test. During the test, the sample is kept in a vacuum state with a maximum pressure difference of 2kPa (20mbar), and the pumping speed is less than 40 times the volume of the shell per hour. The test is conducted for 8 hours.
3. Inner diameter of nozzle: 12.5mm;
Water flow rate: 100L/min
Test time: 3 minutes
Distance from nozzle to shell surface: 2.5m~3m.

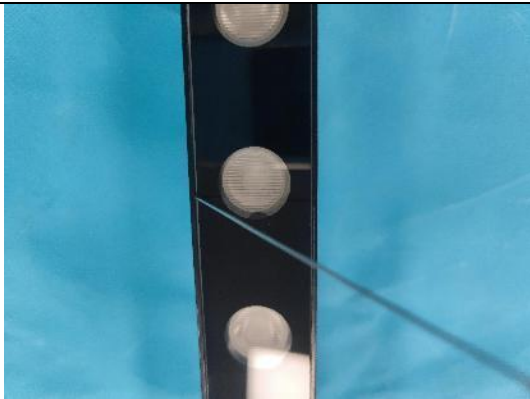
